Following are excerpts from the session.

- **Dr. Fred Gilbert (FG):** This is the question and answer session we hold every fall. We do not come in with any fixed agenda; we're simply here to respond to any questions from the audience on things concerning the University.
- **23. Q:** My question is about wireless technology. We've had in the LUSU office about 30 individuals at least who have talked to me about it, and I'm wondering if you can inform everybody why we don't have it.
- FG: The decision is mine, and it was made on the basis that the jury is still out on the impact that electromagnetic forces have on human physiology. Some studies have indicated that there are links to carcinogenetic occurrences in animals including humans that are related to energy fields associated with wireless hotspots, whether those hotspots are transmissions lines, whether they're outlets, plasma screens, or microwave ovens that leak. One of them is related to cell phones. You're all taking a risk when you use a cell phone. Until we have resolution of the health implications of EMF and until you replace the president, that will be the policy at Lakehead University.
